A salary income earner with total income of upto INR 12.75 lakhs will not pay any tax thanks to the increase in tax rebate from INR 25000 to INR 60000.

MSME Empowerment: Doubling the credit guarantee to MSMEs from INR5 crore to INR10 crore is expected to stimulate small business growth, job creation, and economic resilience.

Manufacturing Mission: The National Manufacturing Mission could significantly advance India's 'Make in India' initiative, promoting large-scale manufacturing and sustainable production, leading to increased global competitiveness.

R&D Investment: Allocating INR20,000 crore for private-sector-driven R&D and innovation initiatives may result in technological breakthroughs and a stronger innovation ecosystem.

I urge you all to carefully review the budget proposals. Our association will be organizing workshops and seminars in the coming days to delve deeper into these changes and their implications. I encourage your active participation in these events to enhance your understanding and better serve your clients. Finally, I encourage all members to contribute articles, opinions, and case studies to our newsletter. This platform is meant to be a collaborative space for sharing knowledge and fostering professional growth.

Union Budget 2025

On February 1, 2025, Finance Minister Nirmala Sitharaman presented the Union Budget 2025-26, introducing several significant measures aimed at stimulating economic growth and providing relief to various sectors. The key highlights are as follows:

1. Taxation Reforms

Income Tax Relief: The new tax regime exempts individuals earning up to ₹12 lakh annually from income tax. The revised tax slabs are:

₹0 - ₹4 lakh: Nil

₹4 lakh - ₹8 lakh: 5%

₹8 lakh - ₹12 lakh: 10%

₹12 lakh - ₹16 lakh: 15%

₹16 lakh - ₹20 lakh: 20%

₹20 lakh - ₹24 lakh: 25%

Above ₹24 lakh: 30%

TDS and TCS Adjustments: The threshold for Tax Deducted at Source (TDS) on interest for senior citizens has been increased from ₹50,000 to ₹1 lakh. Additionally, the annual limit for TDS on rent has been raised from ₹2.4 lakh to ₹6 lakh.

Tax Exemptions: Withdrawals from the National Savings Scheme made on or after August 29, 2024, are now exempt from tax.

2. Agricultural Initiatives

Prime Minister Dhan-Dhaanya Krishi Yojana: A new scheme aimed at enhancing agricultural productivity and farmer welfare.

Enhanced Credit through Kisan Credit Card (KCC): The budget proposes facilitating short-term loans up to ₹5 lakh for 7.7 crore farmers, fishermen, and dairy farmers.

Self-Reliance in Pulses: A six-year mission focusing on pulses like Tur, Urad, and Masoor to boost domestic production and reduce dependence on imports.

Makhana Board in Bihar: Establishment of a dedicated board to promote the cultivation and marketing of Makhana, benefiting farmers in Bihar.

3. Support for Micro, Small, and Medium Enterprises (MSMEs)

Revised Classification Criteria: Updating the definition of MSMEs to ensure more enterprises receive benefits.

Credit Cards for Micro Enterprises: Introduction of credit cards tailored for micro-enterprises to facilitate easier access to credit.

Fund of Funds for Startups: Establishment of a fund to support startups, encouraging innovation and entrepreneurship.

4. Investment in Infrastructure and Innovation

Public-Private Partnerships (PPP): Encouragement of PPP models to develop infrastructure projects across the country.

Research and Development: Allocation of ₹20,000 crore to implement a private sector-driven research, development, and innovation initiative.

PM Research Fellowship: Provision of 10,000 fellowships for technological research in premier institutions like IITs and IISc.

5. Export Promotion Measures

Incentives for Electronics and Electric Vehicles (EVs): Exemptions granted for components like open cells used in LED/LCD TVs and capital goods for lithium-ion batteries used in mobile phones and EVs.

Leather Industry Support: Full exemption of basic customs duties on wet blue leather to promote domestic consumption and enhance exports.

These initiatives reflect the government's commitment to fostering economic growth, supporting key sectors, and providing relief to taxpayers.
